I am pleased to enclose the Draft Annual Remuneration Report for 2026–27. This report outlines the Commission's proposed determinations on the remuneration, expenses, and benefits for elected and co-opted members across Wales' principal

councils, community and town councils, fire and rescue authorities, and national park authorities.

This is the first draft report since the Commission assumed responsibility for this remit from the Independent Remuneration Panel for Wales. It reflects a continuation of the robust framework inherited, while also initiating a forward-looking review of key areas including:

- · Resettlement payments for councillors who are unsuccessful when seeking reelection;
- · The remuneration framework for senior roles in principal councils and corporate joint committees;
- The methodology for annual uprating, including considering whether the Annual Survey of Hours and Earnings remains the most appropriate measure;
- · Ongoing engagement with stakeholders such as the Welsh Local Government Association and One Voice Wales.

The Commission has proposed that the basic salary for elected members increases to £21,044, in line with the rise in average earnings. The increase in the basic annual salary is 6.4%, and we propose to maintain the existing banding structure for senior roles. Further details, including specific salary levels and allowances, are set out in the enclosed report.

The draft is now open for consultation until <u>18 November 2025</u>, and the Commission welcomes feedback from all stakeholders to inform the final determinations, which we intend to publish by the end of the year.

Launch of tRESP Consultation



We are pleased to announce the launch of the transitional Regional Energy Strategic Planning (tRESP) consultation. The consultation is open for six weeks from **23 September 2025** to **3 November 2025**.

What is tRESP?

Ofgem has asked NESO to take on a new regional energy strategic planning (RESP) role. The role will bring changes to the way that electricity and gas distribution networks are planned across Great Britain.

Eleven bespoke regional energy strategic plans (RESPs) will be produced for Scotland, Wales and nine English regions. These plans will then be used as key inputs to the business plans for the electricity and gas distribution network companies. This will help to ensure that energy networks are supporting the

delivery of local and national ambitions for economic growth and net zero. The first set of full RESPs will be published by the end of 2027.

tRESP has been developed to act as a bridge between the current approach to local energy network planning, and the new RESP approach.

tRESP is focused on supporting the next round of electricity distribution network operator (DNO) business plans, for 2028-33, also known as the ED3 price control. In order to fit with the timescales for the development of the DNO plans, we need to publish tRESP by the end of January 2026.

Why a consultation now?

We've taken a collaborative approach to the development of tRESP. We've been sharing our work and inviting, and taking on board, comments from stakeholders since March 2025. We're continuing this approach for the tRESP consultation, using it as an opportunity to share and invite comments on our latest work in progress. By consulting with our customers and stakeholders now, this will help us to meet the January 2026 deadline.

Consultation scope

We are seeking your feedback on:

- **Contexts for the Nations and Regions:** overviews for each RESP nation and region, based on publicly available data and information we've gathered through our engagement to date in England, Scotland and Wales
- **Pathways:** short- and long-term routes to net zero for each nation and region, prioritising demand and generation technologies that will contribute the most to peak demand increases in the future
- **Consistent Planning Assumptions:** a set of assumptions to ensure DNOs take a consistent approach in using the tRESP pathways
- **Strategic Investment Need:** identifying key projects requiring investment in electricity distribution networks but which are not yet in the connections process.
